





### Reading 10 F Shop Locally

<sup>1</sup>Lately, news about the economy has been bad. <sup>2</sup>Times are tough for families because they don't have as much money. Local businesses are closing. <sup>3</sup>One way to help the economy is to shop at local small businesses. Shopping locally means buying items from friends and neighbors, <sup>4</sup>and supporting their businesses.

<sup>5</sup>Shopping in local stores helps more than just the business owners. Local stores are often cheaper and have more dedicated workers. The owners of the stores want to make shopping a good experience for the customer. This builds customer loyalty, which is also better for the customers.

<sup>6</sup>Local businesses have fresher food and better quality products. <sup>7</sup>They buy their food fresh from local farmers. This food comes straight from the field to the store. The other goods they sell may be more detailed and well made because many local businesses sell fewer items. <sup>8</sup>Local businesses do not have the ability to support the manufacturing of large quantities of products in factories.
