

# How to Prepare for Public Release 2024

Kentucky is currently in the process of releasing 2023-2024 assessment and accountability data.

The U.S. Department of Education (USED) requires states to implement school accountability and school identification requirements for the 2023-2024 school year. <u>Kentucky's accountability system</u> includes an exclusive list of six state indicators that measure school performance:

State Assessment Results in reading and mathematics

- State Assessment Results in science, social studies, and writing
- English Learner Progress
- Quality of School Climate and Safety
- Postsecondary Readiness (high school only)
- Graduation Rate (high school only)

The accountability system's overall performance for each district, school and student demographic group determined by the state indicators shall combine current year performance, called "Status" and improvement from the prior year to current year, called "Change."

For each state indicator, there are five Status Levels, ranging from Very High to Very Low and five Change Levels, ranging from Increased Significantly to Declined Significantly. Indicator color ratings are based on the combination of Status and Change using a 5 X 5 table.

Overall Performance Ratings will be reported using a color rating system to communicate performance of schools. Color ratings will include five performance levels from highest to lowest, Blue, Green, Yellow, Orange and Red.

Kentucky continues to have federal accountability and school identifications of Targeted Support and Improvement (TSI) in the 2023-2024 school year. Beginning with the 2022-2023 school year, schools will be identified for Comprehensive Support and Improvement (CSI) and Additional Targeted Support and Improvement (ATSI) every three years afterwards. The next identification of CSI I, CSI II, and the newly identified ATSI will be in 2025.

To assist districts with public reporting this year, the Office of Assessment and Accountability (OAA) has updated <u>public release resources</u>. To begin this process, education leaders should be prepared for the public release. The following steps may assist with preparation.

### Step 1: Get to Know the Components

To assist with understanding of the school and district performance, education leaders may benefit by reviewing the components that are currently available. The following training materials and other data release resources will assist with understanding of the different pieces of the assessment and accountability systems.

## Step 2: Access the Data

The chart below includes information helpful for accessing the systems where data is located. School and district leaders will need PearsonAccess<sup>next</sup> (PAN) for the Kentucky Summative Assessment (KSA) and Alternate Kentucky Summative Assessment (AKSA) individual student scores, the Student Data Review and Rosters (SDRR) application for completing the data review process after public reporting, the web applications login for reviewing secure documents (i.e., individual school/district spreadsheets with summary data information) and initially Open House and later, the School Report Card (SRC) for school and district test results, teacher qualifications, etc.
