

August Assessment Data Release

August 2, 2024

The Office of Assessment and Accountability (OAA), in collaboration with Pearson, released individual student assessment results for the Kentucky Summative Assessment (KSA) and Alternate Kentucky Summative Assessment (AKSA). The combined report contains results for both the KSA and AKSA. The following reports are available in <u>Pearson Access Next</u> (PAN):

- Combined Kentucky Summative Assessments School Listing (District level)
- Kentucky Summative Assessment District School Listing Data File (District level)
- Kentucky Summative Assessments School Listing (School level)

Who can view individual student data?

The KSA and AKSA student data may be shared with teachers and administrators who have an educational interest in the student (i.e., to prepare for instruction, identify strengths and areas for growth, etc.). OAA does not require that districts have teachers sign an Embargoed Data Non-Disclosure; however, the data available in PAN is individual student data. To comply with FERPA laws, individual student data is never released to the media or shared publicly.

The <u>Student Data Review and Rosters (SDRR)</u> application was open for quality control (QC) data review of individual student data for the following:

- ACCESS
- Alternate ACCESS
- Kentucky Summative Assessment (KSA)
- Alternate Kentucky Summative Assessment (AKSA)
- Four-Year (2023) and Five-Year (2022) Cohort Graduation Rate
- Postsecondary Readiness (PR)

Who can view the data during the QC data review process?

Schools and districts should not share any aggregate data (e.g. cohort) beyond the leadership level during the QC process and all the data must be kept secure until public reporting. The data cannot be shared through email or in any public meetings.

Kentucky Summative Assessment (KSA) and Alternate Kentucky Summative Assessment (AKSA) Reports available in Pearson Access ^{Next} (PAN) for district use. Each school will receive school level reports. The District Summary Report is available at the district level only.

Paper Individual Student Reports for the Kentucky Summative Assessment (KSA) and Alternate Kentucky Summative Assessment (AKSA) will be distributed to districts to be shared with families.

Who can view the assessment data reports in PAN?

The KSA and AKSA student data released in August and September may be shared with teachers and administrators who have an educational interest in the student (i.e., to prepare for instruction, identify strengths and areas for growth, etc.). The OAA does not require that districts have teachers sign a Non-Disclosure Statement for this data.

To comply with FERPA laws, individual student data may not be released to media or shared publicly which is what the Non- Disclosure Statement covers. Results may be shared with students and parents **when paper versions** of the Individual Student Reports are available in late-September or early October.

Released items resources from the spring 2024 KSA will be available on the Kentucky Portal.

Released items student data from the spring 2024 KSA will be available in PAN.

• Released Items data files for reading, math, science, social studies, editing and mechanics and on-demand writing for grades 3-8, 10 and 11.

Who can view the released items resources?

The KSA released test items are drawn from previously administered assessments and are provided for instructional planning purposes. They are not a definitive representation of what will be included on future assessments. Once a test item is released publicly, it is no longer eligible to be included in the state administration of the KSA, therefore the released test items can be viewed and shared with teachers, students and families.

KSA released items data provide evidence of student learning that helps to inform decisionmaking related to teaching and learning. Along with other data at the school level, these data can provide insight into student outcomes and provide a clearer picture of school performance.

The data may be shared with teachers and administrators who have an educational interest in the student (i.e., to prepare for instruction, identify strengths and areas for growth, etc.).

Open House/ School Report Card Update

The Kentucky Department of Education will release 2023-2024 assessment and accountability data in a phased approach this fall. The data will be released in datasets in Open House before the new School Report Card (SRC) dashboard is available. This platform provides comprehensive information on school performance, enabling stakeholders to review and analyze educational outcomes.
