4-Course Identification for Valid Pathways Begins March 1

The time is coming for schools to identify the primary 4-course sequence that will be offered to claim a valid, fundable pathway. Training for this process will begin in March. This training is SEPARATE from your required TEDS training and should last less than an hour. In the meantime, we have posted an [FAQ for Course Identification](#). Accurate course identification determines whether your pathway can be funded. Test Tickets, Test Tickets, Test Tickets!

Here are some important things to know about EOP and TRACK test tickets:

1. If your students passed the Horticulture and Plant Science EOP in the past, they may get a test ticket again. This is because the name changed and TEDS now sees it as a new test. Don't worry, they do not have to take the test again. Simply securely destroy the ticket.
2. The window for verifying your test tickets has closed. Remember, you still must verify that you got the tickets you should have gotten. As of February 1, the test ticket report will not update. Unfortunately, we cannot find a way to make updates for incorrect information.
3. It is the responsibility of the school to ensure data is entered correctly. If the student is unable to take an EOP assessment due to inaccurate data entry, it is the responsibility of the data entry staff and the school. If those students are not seniors and they take a course next year (the 2024-2025 school year), their data can be updated at that time, and they would then be eligible to take an EOP assessment in the spring of 2025. If they are seniors, they are eligible to take an [industry certification assessment](#).

How Clean Is Your Data?

Clean data is happy data. It is often this time of year that we notice the problems with our data. It is also the time of year when I have to think, “Can I find the right words (to say)” when I have to tell you that your data is not clean and cannot be fixed at this point. The only words that come to mind have become a bit repetitive. If you want clean data:

- ◇ When you enroll students in pathways,
 - ◆ The student should know they are in that pathway (no surprises).
 - ◆ The correct credit hours must be posted. Then, **credit hours must be updated whenever they change on the official transcript** (e.g., end of semester/trimester).
- ◇ When a student earns an industry certification for their chosen pathway, it should be properly entered in TEDS as soon **as the information is received from the instructor** and in the same school year it is earned.
- ◇ Once a student meets the definition of concentrator, that should be properly noted in IC and **imported** into TEDS when it happens.
- ◇ **You must review and update the data one last time at the end of the school year** (before your local IC is locked for the year) to **ensure data accuracy**.
- ◇ **NO DATA HOSTAGES. Clean data is happy data.**

Miscalculations or forgetfulness can hurt the school, the district and most importantly, the student. That is a mistake that can last for the longest time. **NO DATA HOSTAGES.**

Co-Op Rules

I am determined. I will find a way to make sure everyone knows about co-op. Co-op guidance is a legislative mandate. This mandate can be easily overlooked, but you must follow the co-op regulation, [705 KAR 4:041](#) as written.

A student must fit one of these categories:

- a. Be enrolled in a course included within the student’s chosen career pathway within the same academic year;
- b. Be a completer in the career pathway they are co-oping in by the end of their junior year; or
- c. Be Enrolled in an approved pre-apprenticeship program.

If your student does not meet one of these criteria, they cannot legally co-op.
