#### How Clean Is/Was Your Data?

The school year has ended. Hopefully, you can take advantage of opportunities to sleep in late and get a little rest. The goal is to not have to say "last night I had the strangest dream" and then recount how you thought all of your data was correct and on time. Before you drift off into the land of summer slumber, take one last look at your data.

- Were all your students are enrolled in pathways,
  - ♦ They should know they were in that pathway (no surprises)
  - The correct credit hours must be posted. Then, credit hours should have been updated at the end of the school year to match the transcript.
- When a student earned an industry certification for their chosen pathway, did you enter it in TEDS?
- Did that student meet the definition of concentrator at the end of the year when transcripts posted? Did you move them to concentrator and submit it to TEDS?
- You must review and update the data one last time at the end of the school year (before your local IC is locked for the year) to ensure data accuracy.

#### Adding New Pathways and Modification Requests for 25-26

When I was in school, Keith Sweat wanted to make it last forever. However, Echo and the Bunnymen are more realistic. They know that nothing lasts forever. Just like your opportunity to add a new pathway or make small edits/ modifications to your existing pathways. It may seem like a far way off, but the deadline will hit you quicker than the end of summer. Don't wait. Review the step-by-step guide for how to **Request to ADD or REMOVE a Pathway**. Just remember: if you want to add the pathway for 2025-2026, you will need to complete the process before September 1, 2025.

June 15	TEDS End of Year Data entered in IC and imported to TEDS
	(Remember to check ALL students, not just active)
	<ul> <li>Semester Data (credits, student objectives, etc.)</li> </ul>
	** MUST be completed BEFORE local IC End of Year Script is run
July	Career Readiness data pulled for the Office of Assessment and Accountability (OAA)

#### **Closing Tasks**

The end of the year is quickly approaching, but there's still work to be done, so we will say it one more time. We hope you're not tackling this project alone. Having a second set of eyes on your work is not just helpful - it's essential. It is critical to check and double-check your data. As you prepare to close out your TEDS data, make sure to review the following:

- **School deadline**. Do you know when your school's Infinite Campus will close for the year? If you don't know, find out. You need to complete your last export before that date.
- Remember:
  - ⇒ You cannot remove an end date on the TEDS tab in Infinite Campus unless the student is currently enrolled in a class in that pathway.
  - ⇒ If you remove the end date on the TEDS tab in Infinite Campus during the current Infinite Campus year (2024-2025), the student will remain active in TEDS. If the student is NOT in a course in a valid pathway during the current school year this will be counted as a data violation and potentially a funding violation as well.
  - ⇒ If you remove the end date on the TEDS tab in Infinite Campus AFTER YOUR IC HAS BEEN CLOSED FOR THE CURRENT YEAR (2024-2025), the student will be active in Infinite Campus for 2025-2026 even if they are NOT in a course in a valid pathway in 2025-2026. This will be counted as a data violation and potentially a funding violation
- **Credits**. Make sure what is in TEDS has been updated to match the transcript (through your final export/import process) at the end of the year BEFORE you leave for the summer.
- **Student Objective**. Again, make sure what is in TEDS has been updated to match the TEDS tab in IC (through the export/import process) Is this student exploring or a concentrator? Are you sure?
- **Industry Certifications**. Have all attempts at industry certifications been entered in TEDS? Have all the teachers verified that they have provided all the information?
