**Agenda Item:** Introduction and Roll Call

**Presenter:** Julia Roberts, SACGTE Chairman, Western Kentucky University

**Summary of Discussion:** Julia Roberts called the roll and the secretary noted attendance.

**Agenda Item:** Gifted Student Services Plan in Infinite Campus

**Presenter:** Kathie Anderson, Gifted Education Program Consultant, Division of IDEA Implantation and Preschool

**Summary of Discussion:**

Kathie Anderson presented background and regulation on the Gifted Student Service Plan (GSSP). Roberts commented on the law and regulation of the education plan. Kirk Haynes stated the proposed GSSP looks different from what he has seen from other GSSPs. Hilary Morton noted some districts do have different versions. Anderson discussed pros and cons of the current GSSP form. Morton informed members regarding the interactive/transfer

explanations between districts. Brenda Martin asked if parents can have plans changed. Brandy Corbin stated there is a process at the school level to change these plans.

Paulynn Covington discussed navigating Infinite Campus (IC) and changing plan may be good to have more communication to resource teacher. Jeanne Lee suggested using the comments section. Haynes discussed ability to click a template.

Anderson continued with proposed changes. Haynes asked about the current GSSP document and if new form would have footnotes and or header. Covington asked if there is an option to add another page for most critical information. Morton stated the Gifted and Talented (GT) record generate the proposed GSSP. Kim Nettleton asked if this could be updated year to year. Corbin asked for clarification on the page as a parent. Covington asked about non-English speaking translation. Morton stated she would ask Infinite Campus about translation. Martin asked about clarification of who declined services, school v. parent.

Anderson shared pros and cons of the proposed GSSP. Jeanne Lee asked about history. Anderson summarized the history and ability to save. Lee asked for clarification on ability to save a GSSP in IC. Anderson stated the history would need to be saved to PDF. She stated import of record will still be available.

Martin asked about audit of transferred student record. Jeanne Lee described transferred student resource evaluation.
