Agenda Item: Committee Meetings

Presenter: Julia Roberts, Chair of the SACGTE

Summary of Discussion: Anderson went over Committee Expectations and goals for today's work session: to create recommendations for the Kentucky Department of Education (KDE) and provide rationale for that recommendation. Members then divided into groups for a work session.

Agenda Item: Committee Reports

Summary of Discussion: Priorities Worksheet

The committees made the following recommendations:

Equity in Identification Committee Members:

KDE will support professional development of district and school leaders that highlights
the appropriate identification of Gifted and Talented (GT) students and the benefits of
GT education toward closing excellence gaps and ensuring equitable learning
opportunities across the state. Learning should be endorsed, provided, and distributed
through regional educational cooperatives, Kentucky Association for School
Administrators and Kentucky School Board Association and Commissioner Glass.

- KDE will provide a diagnostic process as part of the Needs Assessment for Continuous District Improvement Plans/Continuous School Improvement Plans processes that includes GT students in Multi-Tiered Systems of Support plans.
- KDE will continue to provide guidance to GT coordinators, school administrators, GT teachers and school GT Identification and Selection Committees regarding best practices to identify students for GT education services that includes special considerations to address equitable access to GT services.

Summary of Discussion: Kim Nettleton suggested something be added that includes other avenues of identification other than testing. There was also discussion about the appeal process for parents if they feel that their child has not been properly identified. There was discussion around including informing families of processes and their rights.

Accommodations for Identification and Testing Committee Members:

 The committee recommends that a statement be added to the GT handbook under Section 3 to address/clarify that students who receive special education services and have accommodations in their Individual Education Program, be given those accommodations during testing for identification for gifted services. The addition of this statement would also draw attention to the fact that twice exceptional students are often overlooked for receiving GT services.

Summary of Discussion: The committee was interested to find that less than 3% of GT students who are identified in the state are also identified as students having a disability. Another point of interest was that only 254 of the over 86,000 identified GT students in the state were foster children.

Social Emotional Support Committee Members:

- Gifted students should be included as a subgroup identifier for disaggregation in identification in all areas. This should be incorporated in all reports as an exceptionality. In statewide reports, include GT as a subcategory in areas.
- KY Stats should develop a GT profile to gather and display consolidated data on GT students
- KDE will require professional development by administrators, teachers and school counselors on the social and emotional needs of Gifted students.

Summary of Discussion: The committee noted that much of the information on social-emotional issues is anecdotal and there is often not data. The committee also noted that there is a need for further social/emotional information and tracking and reporting for foster children or under the radar children. There were also concerns with recommending more professional development for teachers, which places a burden on them and also on school districts who may have to pay teachers for extra days to get all their training completed. A balance needs to be found between not overburdening school districts and also still getting the necessary information out to best serve the needs of GT students.

Summary of Discussion: Roberts shared that the Talent Identification Program of KY has officially launched and there is a talent search for 4th-6th grade students. The test used items planned for 8th graders to accurately identify where gifted students are performing. It is statewide and available to all. WKU is also partnering with John Hopkins with Project Launch Plus. Any 6th grader who lives within three hours of Bowling Green is eligible to participate in Discover thanks to this grant. Half of the grant funding will be slated for summer programs and it will also be used to make students aware of other opportunities. Roberts also reminded members of the Victoria Fellows program for Superintendents, as well as cohorts for elementary and middle school principals.
