Agenda Item: American Rescue Plan (ARP) Team Discussion

Summary of Discussion: Alisha Reeves discussed the American Rescue Plan funding an early learning team and their work projects to benefit Kentucky's early childhood programs. Projects such as the positive behavioral intervention and support (PBIS) Pyramid Model, Office of Special Education and Early Learning guides, teacher leader communities and the United We Learn vision were discussed.

Agenda Item: Mixed Delivery Models Discussion

- 3. How can the council help relieve preschool teacher frustration to reduce the teacher turn over to kindergarten?
