Agenda Item: Welcome

Presenter: Thomas Woods Tucker, Deputy Commissioner, Kentucky Department of Education

Summary of Discussion: Tucker welcomed everyone to the meeting and expressed gratitude for their work. He shared several announcements, including updates on the new assessment and accountability system, the Persistence to Graduation Summit, the Kentucky Reads to Succeed summer conference, and the Kentucky Coalition for English Learners Summer Institute. Tucker closed by thanking members of the PrAC for their work and emphasizing the importance of principals in providing continuity to students, families and communities amidst challenges.

Agenda Item: Legislative Updates

Presenter: Cassie Trueblood, Office of Educator Licensure and Effectiveness, Kentucky Department of Education

Summary of Discussion: Trueblood provided an overview of Senate Bill (SB) 181, which requires local **b**oards of **e**ducation to designate a traceable communication system for school district employees and volunteers to communicate with students. She explained the requirements for principals to notify parents and handle complaints of unauthorized electronic communication. Trueblood emphasized the importance of principals working with their school board, superintendent and local board attorney to ensure implementation compliance with this legislation.

Trueblood directed attendees to key resources to stay informed. She shared a direct link to the KDE webpage containing official guidance related to current legislative changes. Additionally, she provided supplementary links to resources that address the legislative process and offer insight into the passage of education-related bills.

Feedback: Participants discussed concerns about the implementation of SB 181, including the impact on coaches and the need for training staff and the public on new requirements. Various communication tools like ParentSquare and TalkingPoints were mentioned as potential solutions.

Agenda Item: House Bill 48

Presenter: Todd Davis, Office of Educator Licensure and Effectiveness, Kentucky Department of Education

Summary of Discussion: Davis explained that House Bill 48 changes the certified evaluation process, requiring a five-year summative evaluation cycle for all tenured teachers and administrators. This replaces the previous three-year cycle for teachers and one-year cycle for administrators. Davis emphasized the need for districts to update their certified evaluation plans (CEPs) to comply with the new five-year cycle. He advised working with 50/50 committees to adjust the evaluation process accordingly.

Davis mentioned that districts have some flexibility to conduct more frequent evaluations on a case-by-case basis, particularly if performance issues arise. However, this cannot be applied system wide. The changes take effect in the 2025-2026 school year, and districts must ensure their CEPs are updated and approved by their local boards in time for the new school year. Davis encouraged members to reach out to him for additional information or questions.

Agenda Item: New Go Teach KY Website

Presenter: Stacy Noah, Office of Educator Licensure and Effectiveness, Kentucky Department of Education

Summary of Discussion: Stacy Noah and Elly Gilbert introduced the new Go Teach Kentucky website, highlighting its features and resources. Gilbert highlighted the website's four main sections: Grow Your Own, Certification Information, Educator Prep Programs and Professional Growth and Leadership. Each section offers specific resources and guidance for educators at different stages of their careers. Gilbert demonstrated the "Find Your Path" tool, which helps users navigate the teaching profession based on their status, such as high school students, college students, college graduates, or career changer. This tool provides tailored guidance for each pathway. Also, Gilbert introduced the alternate pathway form, a logic-branching tool that guides users through the process of becoming a certified teacher based on their qualifications

Noah highlighted the Principal Partnership Project (P3) section, which offers resources for aspiring and current principals, including professional standards, tools and resources, and professional learning opportunities.
