Agenda Item: Welcome

Presenter: Robbie Fletcher, Commissioner, Kentucky Department of Education

**Summary of Discussion:** Fletcher welcomed everyone to the meeting, discussed the unusual challenges (i.e., flooding, snow, high winds) faced during the school year, and shared updates on his visits to various districts affected by natural disasters. He also mentioned the productive conversations with legislators and the tracking of education-related bills.

## **Agenda Item:** Legislative Updates

**Presenter:** Cassie Trueblood, Office of Educator Licensure and Effectiveness, Kentucky

**Summary of Discussion:** Trueblood provided an update on the current legislative session, mentioning the high number of bills and the importance of tracking their progress. She also shared resources for following committee schedules and bill statuses with the group.

**Feedback:** Jarrod Hankins, PrAC member, asked for a status update about the legislation related to making up time for schools that have had to cancel in person learning. Fletcher shared the progress of House Bill 241 which emphasizes a requirement change from 170 days to 1062 hours. Trueblood shared the link to House Bill 241.

# **Agenda Item:** Needs of School Principals

**Presenter:** Joseph "Rocky" Wallace, Campbellsville University, and Nicholas Brake, Western Kentucky University

**Summary of Discussion:** Wallace and Brake represent the University Principal Preparation Initiative (UPPI) group which is comprised of principal preparation providers who meet eight times each year. The UPPI group partners with the Kentucky Department of Education (KDE) to ensure strong principal preparation programs are in place across the Commonwealth. The UPPI group has recently started research for a Whitepaper focused on the needs of Kentucky school principals that will be shared with state partners. Wallace and Brake are excited to be part of the PrAC group and hope to learn much from the PrAC meetings that will ultimately support the development of the UPPI research project.

Sudduth also provided information on the recently updated parent and family engagement guidance, highlighting the importance of building parent capacity and seeking parent input in designing and implementing programs.

**Feedback:** Eerenberg shared the House system that Boyd County implemented. He noted its purpose is to create a small family within the large family of the school population. Additional examples were provided by the group and Sudduth encouraged PrAC members to share their innovative practices through a Google form.
