

- An overall performance rating for elementary, middle and high schools reported using a color rating system to communicate performance of schools, with red being the lowest rating and blue being the highest rating
- Color ratings to include five performance levels from highest to lowest, blue, green, yellow, orange and red

Accountability 2022-2023 and beyond

- Beginning in the 2022-2023 school year, Accountability indicators are based on **Status and Change**.
- Status and Change will combine to determine indicator performance rating (color).

5 x 5 Colored Tables (beginning 2022-2023)

As defined in SB 158, KDE and the Local Superintendent's Advisory Council (LSAC) will approve the numerical cut scores that move performance from one cell to another. Charts will appear in Kentucky's Every Student Succeeds Act (ESSA) Consolidated State Plan.
