Commissioner Glass Presents to House Education Committee on Teacher Shortage

- On Feb. 7, the commissioner was one of several people asked to present on Kentucky's teacher shortages to the House Education Committee.

- Glass said the shortages all come down to three main things: pay, support and respect.
- Glass said, "If we work on increasing total compensation, support for our educators and respect for our educators, I believe we can begin turning the tide on this difficult issue."


2024 Kentucky Teacher of the Year Update

- Applications for the 2024 Kentucky Teacher of the Year program are due Feb. 21.
- More than 1,125 teachers were nominated by their peers, students, principals and others in the community for award consideration.

Kentucky Celebrates 104 New National Board Certified Teachers

- Kentucky recognized 104 teachers newly certified by the National Board for Professional Teaching Standards during a Feb. 9 virtual ceremony.
- Kentucky has the ninth-largest class of newly certified National Board Certified Teachers (NBCTs) nationally.
- These educators join more than 4,283 teachers across
 the state who have gone through this highly reflective and
 transformative professional development. Nearly 1,400 of
 their colleagues currently are pursuing certification.
- Kentucky ranks sixth based on the total number of NBCTs as a percent of the 2021-2022 teacher workforce in each state.

Kentucky EPSB Hears About Interstate Compact Related to Teacher Licensing

- The Kentucky Education Professional Standards Board (EPSB)
 met on Feb. 13 and discussed an interstate compact to facilitate
 mobility of teachers across member states.
- The Interstate Teacher Mobility Compact addresses district-andschool-level hiring barriers associated with out-of-state applicants in its current draft form.
- It establishes an adaptive, responsive licensing structure for educators who might move across state lines.
- It is designed to expedite the teacher certification process for experienced, quality educators.

- Applications for a position on the CSAC must be submitted online by March 9 at 11:59 p.m. ET.






Applications Open for Nonvoting Student KBE Member



Legislative Process

- Last day for bill filings
 - Senate: Tuesday, Feb 21
 - House: Wednesday, Feb 22
- Veto period: March 17-28
- General Assembly reconvenes March 29
- Sine die March 30

Bills of Interest

- HB 1: Income tax
- HB 3: Juvenile justice
- HB 13: Increase the time period allowed for the required physical examination for bus drivers from 12 to 24 months
- HB 17/HB 35: Full-day kindergarten
- HB 18: Dual credit scholarships
- **HB 20:** Increase the minimum amount for advertising and bidding school building projects from \$7,500 to \$30,000



Bills of Interest (Part 2)

- **HB 30:** Ensure that student privacy exists in school restrooms, locker rooms and shower rooms
- HB 32: Allow for the hiring of classified personnel without a high school diploma or equivalent
- HB 33: Innovative Teacher Education Grant Program
- **HB 41:** Foster care student toolkit
- HB 50/SB 50: Make school board elections partisan
- HB 82: Require rather than allow local boards of education to develop policy on dyslexia
- HB 88: Funding for education initiatives (Gov's proposal)
