The District shall not allow nonresident students to enroll in the District.

☐ The District shall allow nonresident students to enroll in the District pursuant to existing Admissions and Attendance Policy 09.12, Tuition Policy 09.124, and related procedures.

Upon allowing nonresident pupil enrollment, the policy shall allow nonresident children to be eligible to enroll in any public school located within the District. The policy shall not discriminate between nonresident pupils, but may recognize enrollment capacity, as determined by the District. The nonresident pupil policy and any subsequent changes adopted by the Board shall be filed with the Kentucky Department of Education no later than thirty (30) days following their adoption,<sup>1</sup>

#### DEFINITION

Nonresident students are those students who reside with their legal parents/guardians outside the boundaries of the District. Residency cannot be established through living with a relative or friend within the District.

#### CRITERIA FOR ENROLLMENT Admission

All non-resident students wishing to re-enroll for the coming school year must submit an application by June 30. Admission of each non-resident student must be approved annually by the Board and will be considered at the regular July meeting. The following criteria will be used to evaluate each application:

- 1. Classes or grades affected must be within class size restrictions. A reasonable margin must be maintained for possible resident new enrollment
- 2. Students must have and maintain a cumulative 2.5 grade point average on a 4.0 scale. Students must be age-appropriate for the grade in which they are enrolling. Students who have been retained more than one time shall not be considered.
- 3. Students must have at least a 95% attendance rate for the previous school year and must maintain that rate.
- 4. Applicants shall not be accepted who have experienced discipline problems. Reenrollment decisions shall be based partly on the recommendation of the Principal, however, suspension or expulsion shall automatically be grounds for denial of enrollment. New applicants shall be required to present a recommendation from their previous school. Students who have expelled from their previous school shall automatically be denied enrollment.

#### TUITION

The parent(s) or legal guardian(s) of nonresident students may be charged a tuition fee established by the Board.

#### RECIPROCAL AGREEMENT

When a reciprocating agreement provides for one to one exchanges between districts, students in the District shall be eligible for exchange based on their seniority on a waiting list established by the Board.
