- If Districts do not use Five Disaster Relief Student Days (NTI days 11-15) or have days waived after June 4th districts may choose to drop 10 low attendance days instead of the traditional 5 days
- Districts using any of the Five Disaster Relief Student Days or any waivers after June 4th will select the traditional Five (5) Low Attendance Days
- All other Districts will select either RL Five (5) or Ten (10) Low Attendance Days when running your SAAR report

- All depends on the attendance of each day
 - Both present attendance and absences are dropped
- District Support cannot calculate two options for 157 districts

If you want to calculate for your district

- 1. Run Daily Attendance Report/Covert to Excel
- 2. Aggregate 5-10 day total
- 3. Run SAAR with 5 days dropped
- 4. Calculate for 5 days then 10 days
 - 1. Record 7 shows positive attendance and absent attendance (in two groups add together)
 - 2. For 5 days, subtract absent attendance from present and divide by days minus 5
 - 3. For 10 days, subtract absent attendance from present then remove 5-10 day total from Daily Attendance Report and finally divide by days minus 10



 - HB241 Waives 170-day requirement, districts only required to meet 1,062 hours
 - Reminder If local board has approved Amended Calendars and district dismissed school due to weather or other events – Local Board MUST approve calendars again.
