RE: FACPAC & KFICS

The District Facilities Branch (DFB) will implement the initial phase of the FACPAC (<u>Facilities Planning and Construction</u>) system beginning July 1, 2017. The initial phase will provide online versions of the following construction forms:

BG-1 Project Application Form Contract Summary Purchase Order Form Change Order Supplemental Information Form BG-4 Contract Closeout Form BG-5 Project Closeout Form

To facilitate the transition to FACPAC, KDE's data base will undergo a conversion process beginning June 23, 2017. Consequently, during the period from June 23 through June 30, DFB will only be able to process submittals that do not require data base entries.

Districts' ability to upload the above listed documents and the Purchase Order Summary Form to our SharePoint site will be eliminated after June 23, 2017. However, all other submittals must continue to be uploaded under existing procedures until future phases of FACPAC are implemented.

Beginning July 1, 2017 districts will be able to fill out the forms listed above in FACPAC, attach other required documents and submit in FACPAC. FACPAC will provide districts and their designated third parties the ability to track the status of these submittals on a project basis. An important change to note is that initial BG-1 Project Application Forms and BG-5 Project Close Out Forms must be submitted by the district. Permissions for third parties (design professionals and fiscal agents) to access the system will be granted as requested by the district after the initial BG-1 is approved.

As future phases of FACPAC are implemented and KFICS (<u>Kentucky Facility Inventory and Classification System</u>) progresses, the construction process and the planning process will become fully integrated, expedite our reviews and communications with districts and their third parties and provide real-time tracking of submittals.

KDE introduced FACPAC's online BG-1 Project Application Form to Finance Officers in mid-June. We will be conducting regional training sessions for both FACPAC and KFICS as described below. You and your staff involved in the planning and construction of Kentucky's K-12 public schools are encouraged to attend.

Ameresco, the vendor selected for the project, will lead the KFICS building assessment training, including a live demo of their AuditPlanner App. Training sessions will last 3 ½ hours. You may register for 1 of the 12 KFICS training sessions at the following link:

A confirmation email will be sent.

Bring a mobile device (smart phone or tablet) with you to KFICS training to download the app and actively participate.

The overview of Facility Planning and Construction (FACPAC) SharePoint application will be conducted by KDE and will last 2 hours. These sessions will be held at the opposite time of the KFICS training each day, including those in London and Kentucky Dam Village.
