**Graduate citation data due to LRC by March 15**

Data requested by the Legislative Research Commission (LRC) from all districts to complete the annual graduation citations presented to 8<sup>th</sup>- and 12<sup>th</sup>-grade graduates by Kentucky legislators is due by March 15. Use the new *LRC 8<sup>th</sup> and 12<sup>th</sup> Directory ad hoc report* in Infinite Campus to create the district's data file and send it directly to the [LRC Grad Data mailbox](#).

Before sharing the data with LRC, the KSIS point of contact must verify that the exported data aligns with the district definition of FERPA directory information and remove the students who have opted out of the district's disclosure of directory information.

**Spring Preschool Enrollment Count**

All information for the [preschool enrollment count](#) should be completed, active, and locked by 5 p.m. local time on March 1. This includes information located on the Enrollment and Pre-school tabs, as well as special education documents. Only children with active enrollments on or before March 1 will be included in the spring enrollment count. KDE will pull data from the weekend Infinite Campus backups on March 4. The [QA Preschool Report](#) can be used to verify preschool counts ahead of the count date. Preschool coordinators will be sent a data verification survey that must be completed by March 4.

## Postsecondary Readiness Report

The new [Postsecondary Readiness Report](#) will replace the [A Transition Readiness HighSchool Report](#) in Infinite Campus (KY State Reporting/KDE Reports/Postsecondary Readiness). The purpose of the report is to help school and district personnel monitor postsecondary readiness for high school students. The report includes academic and career readiness indicators for all students; however, the report does not calculate points for accountability. The Office of Assessment and Accountability has a process they follow to consider all factors, some of which are not addressed in this report.

Academic readiness indicators include ACT, KYOTE, SAT, academic dual credit, and TAR. Career readiness indicators include industry certification, end-of-program assessment, CTE dual credit, apprenticeship, and work-based learning. The report will show if a student has or has not met the benchmark in the reported postsecondary readiness indicators. Districts and schools can utilize the report to track students who are on their way to being postsecondary ready and who already are. ## FAFSA news and updates

SY 2024-2025 FAFSA deadlines – Apply as soon as possible, the FAFSA site opened on Dec. 31, 2023. For Kentucky, awards are made until all funds are depleted. The federal deadline is June 30, 2025. For specific college deadlines and all other aid, check with the financial aid office at specific college or career schools. Additional forms may be required. Some states and colleges use information from the FAFSA form to determine eligibility for their grants, scholarships, and loans.

On Feb. 13, The U.S. Dept. of Education announced that it will make it easier for (postsecondary) schools to process records and spend more time helping students by considerably reducing verification requirements, suspending routine school compliance reviews, and providing flexibility on renewing participation in the federal student aid programs. The Department is deploying federal personnel and allocating \$50 million for technical assistance and support to help build on the better FAFSA and get financial aid packages to students and families as quickly as possible and to make the FAFSA process easier and simpler for colleges, universities, and students.

The 2024-25 FAFSA form reduced questions to roughly 40 from 100, expanded eligibility for federal student aid, including Pell Grants, and provides a streamlined user experience. Since the new 2024-25 FAFSA form became available on Dec. 30, nearly 4 million forms have been successfully submitted. Some 610,000 new students from low-income backgrounds will be eligible to receive Federal Pell Grants due to updates to student aid calculations. An additional 1.5 million more students will be able to access the maximum Pell Grant award, bringing the total number of students eligible for the maximum Pell Grant to over 5.2 million.

## Title I Reporting for 2023-2024

Title I status in Infinite Campus must be updated to match the Title I status submitted on the district Consolidated Application in the Grant Management Application and Planning (GMAP) system. Reference the [Title I Data Standards, Section A](#) for guidance to verify and update school Title I status in Infinite Campus. In addition, a school designated as Title I Targeted Assistance School (TAS) must complete a record on the student Title I Services tab for each student receiving Title I services during the current school year. Reference the [Title I Data Standards, Section B](#) for guidance in completing student records for Title I services.

The 2023-2024 Title I data will be extracted on July 1 from the Infinite Campus reporting warehouse for state and federal reporting and funding purposes. ## KDE and KY Edit reports to be sunset

KDE and KY State Edit reports in Infinite Campus that are no longer valid, being used, or duplicated will be sunset and no longer available. Local KSIS administrators will need to update Tool Rights to ensure that users have the necessary and appropriate access to the reports listed as an alternative to the reports being sunset.

- KDE Reports that will be sunset on March 13 include:
  - A\_Transition\_Readiness\_HighSchool
  - EOC Assessment Report
  - EOC Early Warning Report
  - SRC District Summary Report
- KY State Edit Reports to be sunset with the Campus release on July 10 include:
  - Expulsion Attendance Report (Districts can find expulsion information in the Safe Schools Report and/or the Superintendents Annual Attendance Report (SAAR). Both are located under KY State Reporting.)
  - Accommodations Report (In place of the Accommodations Report, use the alternative localized report located under Student Information/Reports/Test Accommodations (KY)).

Based on district feedback, the KY State Edit Reports/Schedule Gap Report will not be sunset as originally announced.

## QA Courses Report provides a variety of checks on course setup

The *QA Courses Report* helps users independently identify errors in active courses that have at least one section scheduled. To review possible issues for all courses, choose the Only Courses with Setup Concerns option and All for type of courses. *QA Courses Report* identifies specific errors within course setup and provides recommendations for remediation. KDE recommends districts utilize the report to resolve setup concerns from current-year courses before posting grades to the transcript. Fixing course setup before rolling courses forward will eliminate the same corrections from being needed in the new year.

Please note that users must be granted access by their local KSIS administrator to access the *QA Courses Report*. The report pathway is KY State Reporting/KDE Reports/QA Courses.
