Preschool Fall Enrollment Count

All information for preschool enrollment should be completed, active, and locked by the close of business on Friday, December 5, 2025. This includes information located on the General Enrollment and State Program Preschool tabs, as well as Special Education Documents. Only children with active enrollments on or before December 1st will be included in the Fall enrollment count. To ensure maximum funding, use the time between December 1st and December 5th to correct errors in Infinite Campus such as duplicate records, miscoded grade levels, etc. Do not unlock or edit any information in Infinite Campus after the close of business December 5th until start of business December 9th. On December 8th, the enrollment data will be pulled from the district edition of Infinite Campus. Reminders for IDEA Dec. 1 Child Count

Child Count is a snapshot of students with Individual Education Programs (IEPs) on Dec. 1. The official data pull will be the morning of Monday, Dec. 8, 2025.

- Districts should run the <u>IDEA Dec 1 Count Extract</u> as needed to ensure all students appear on the report, which updates in real time.
- The <u>IDEA Dec 1 Federal Submission Validation</u> (FSV) report only updates on Mondays. This represents the exact data that OSEEL would report if data were reported on that Monday.
- The only difference between the reports mentioned above is that the FSV only updates on Mondays and will only report a student on one report (if a student is enrolled in more than one school).
- All documents and enrollments affecting the child count must be locked and in place by the close of business on Friday, Dec. 5, 2025.
- On Monday, Dec. 8, Office of Special Education and Early Learning (OSEEL) will send a survey that you can submit to verify that districts have verified their data.

Read to Achieve and Mathematics Achievement Fund Custom Reports to Be Sunset Nov. 12

The Read to Achieve (RTA) and Mathematics Achievement Fund (MAF) Custom Reports will be sunset on Nov. 12, 2025. The reports no longer align with data being submitted by grantee schools. RTA schools may use the Early Literacy Universal Screener and Early Literacy Diagnostic Screener Custom Reports and MAF schools may use the Early Numeracy Universal Screener Custom Report to check their uploaded data beginning Nov. 12, 2025.

Course Codes 909995 and 909999

Non-Instructional courses: State course code 909995 can be used for Roster Only Non-Instructional courses used to track groups of students for activities, clubs, sports, or testing groups. If 909995 is being used and the coach or sponsor is EPSB certified, assign them as primary teacher. If the coach or sponsor is not ESPB certified, assign a guidance counselor or other administrator as the primary teacher and the coach or sponsor as a teacher.

Instructional Courses: State course code 909999 should be used as a last resort in situations where a current state course code does not exist and there are no existing Kentucky Academic Standards aligned to the course. Therefore, it cannot be used for required courses. Carefully check for existing state course codes before using 909999. Courses using the state course code of 909999 must specify the Core Content Area being taught in each section. The content area and grade level must align with the primary teacher's active credential, or it will result in an Out of Field error. To check if a teacher has permission for a certain Core Content go to their Profile page on KECS, click on Credentials in the left-hand menu, and scroll to the bottom to find Credential Permissions for Active Credentials. See the Guiding Principles For Using Course Code 909999 for more information.

Every course scheduled during instructional time, or that delivers instruction during non-instructional time, must use the state code that most closely represents the content, rigor, students, and teacher certification of a given course as described in the Searchable State Course Codes Database within KECS. Please see the Course Codes Frequently Asked Questions document for more information about selecting the appropriate state course code.

New State Level Test Structures Available for Early Literacy and Early Numeracy Formative Assessments

The Office of Teaching and Learning has created a state test structure for entering early literacy and early numeracy formative assessments in Infinite Campus to allow districts to share formative assessment data with the Kentucky Department of Education. This new approach improves data quality and makes assessment data more useful for reporting and evaluation of early literacy and early numeracy initiatives.

Read to Achieve (RTA) and Mathematics Achievement Fund (MAF) schools are required to use these test structures to submit data and all districts are invited to add formative assessment scores to the new state level structures in Infinite Campus using one of two procedures (manual or batch entry) outlined in the KDE Early Literacy and Numeracy
Test Recording in Infinite Campus guidance document.

New reports will be available for school and district use with the upcoming Infinite Campus release on Nov. 12. The reports are: Early Literacy Universal Screener Custom Report, Early Literacy Diagnostic Screener Custom Report, and Early Numeracy Universal Screener Custom Report.

TEDS Import - New Data Validation Process

As we grow in our data collection processes, there is a need to adjust our data validation process. Beginning October 1, 2025, TEDS import data will be validated based on the SSID, Date of Birth (DOB), First Name and Last Name. If there is a mismatch, users will see the following message Error: The specified SSID and DOB combination does not match the SSID and DOB stored on the existing TEDS student Demographic record. Verify DOB.

USERS SHOULD <u>TEST THE IMPORT</u> EARLY AND OFTEN UNTIL PREPARED TO COMPLETE AN OFFICIAL IMPORT. An error will occur if the data in TEDS does not match what you are attempting to import. If this occurs, verify the following:

- Verify the SSID
- Use documentation (other than Infinite Campus) to verify DOB and name.
- Correct any errors discovered in Infinite Campus, then create new export files from Infinite Campus and **TEST** the import into TEDS.
- If data is verified and there is still an error on import, contact KDE CTE Data Services at kdectedataservices@education.ky.gov.

An import can be tested at any time. Please do not finalize an import until the data is error-free. If an import is finalized with errors, any records with identified errors will not be imported into TEDS.

Infinite Campus Server Upgrades

This winter, Infinite Campus databases will be upgraded to SQL 2022 and relocated to a different data center. As part of this upgrade, all districts that previously did not have a dedicated URL will receive one. KDE and Infinite Campus will offer a virtual question and answer (Q&A) session in November to address questions that have been submitted by districts. Please make sure your local technology contacts are aware of the upgrade and the upcoming Q&A session. Questions should be submitted in advance to KDE Data Services by email.

Campus Support will be creating a case with details on needed actions by district staff and third-party integrations in early November. Downtime is planned for 2-4 days between Dec. 22 – Jan. 2. SSN Removal Tool in Infinite Campus

Some districts have experienced issues with the SSN Removal tool not running as scheduled. K-12 Solutions has provided an update to prevent conflicts with other jobs. Infinite Campus will deploy the fix with the next statewide update – scheduled no later than Nov. 12.
