The report should be used to identify accounts for employees that have left the district that should be disabled or stale accounts that are not being used and could present a security risk.
KY State Reporting   KDE Reports	<a href="#">Adv Courses and Exams</a>	Advanced Courses and Exams reports provide data for students taking Advanced Placement (AP), International Baccalaureate (IB), Cambridge Advanced International (CAI) and Dual Credit (DC) courses. The data includes the number of students taking a course, completing a course, taking the corresponding exam and receiving a qualifying score on the exam; for Dual Credit courses includes the number of students with a qualifying score (qualifying grade in the course is a C or above)

Kentucky Department of Education (KDE) defines chronically absent as a student who is present 90% or less of full-time equivalency. Both reports calculate school/district chronic absenteeism data based on full-time equivalency (FTE) attendance. KDE calculates chronic absenteeism by dividing student's FTE present minutes by FTE instructional minutes and rounding to the nearest whole percent.

KY State Reporting	<a href="#">Dropout Report</a>	The Dropout Report produces a list of students who are considered Dropouts under State guidelines. KY State Reporting	<a href="#">Dual Enrollment Cap Summary</a>	The Dual Enrollment Cap Summary provides a list of students who are subject to the Dual Enrollment Cap in Kentucky attendance reports. Students must have no more than one Primary enrollment and one Secondary enrollment at any given time.
KY State Reporting	<a href="#">English Learner Extract</a>	The English Learner Extract provides a list of students with EL (English Learner) status. Students must have at least one instructional accommodation and at least one EL Service type active during the date range of the report and a program status of EL to pull. This report runs district-wide regardless of the calendar selected in the toolbar.
KY State Reporting   KDE Reports	<a href="#">Enrollment End Status Validation Report</a>	The purpose of this report is to assist school/district staff in the annual verification of high school students enrollment end status. The State Report will account for aggregate totals for Mode of Intervention, Time Frame and Individual Interventions and Group Programs. The FRYSC State Report will provide for detailed counts by category and program title.
KY State Reporting	<a href="#">Funding Gap Audit</a>	This report will identify students without enough time scheduled to generate a full day's attendance funding on a per day basis for the calendar selected in the toolbar. Time scheduled will include scheduled Virtual and Performance Based course minutes. This file is intended for auditing purposes and is not submitted to the state.
Ky State Reporting   KDE Reports	<a href="#">G-Code Validation High School – Aggregate Report</a>	Using the Infinite Campus toolbar, the aggregate report produces a summary, by school of students who have graduated. Users will use this report to identify likely situations where a student's enrollments and last changed dates point to the possibility that attendance could have been removed.
KY State Reporting   KDE Reports	<a href="#">MUNIS EPSB Upload</a>	This report builds a file containing teacher EPSB license numbers for upload to MUNIS. Only active employment assignments with an EPSB license number will be included in this file. The last four digits of the social security number and birthdate are used to find the matching staff record in MUNIS.
KY State Reporting   KDE Reports	<a href="#">Nurse Counts</a>	The purpose of this report is to produce a list of district-hired and contract nurses within the school/district. The report pulls from the district assignment tab for district-hired nurses and the district health service providers tab for contract nurses. The total district nurse count, is an unduplicated count of school-level nurse data.
KY State Reporting   Edit Reports	Overage/Underage Report	This report identifies those students who fall into three potential age based categories that are NOT eligible for ADA funding as defined by KDE. The three categories are Underage Kindergarten, Underage First Grade and Overage. <b>The underage portion of this report has not been updated with the age requirement change from Oct. 1 to Aug. 1 for entry to kindergarten and 1<sup>st</sup> grade. Districts should use the SAAR R9 Over/Under Attendance Detail report to see a list of underage students.</b>

KY State Reporting	<a href="#">Retention Report</a>	The Retention Report produces a list of students who have been retained (do not advance to the next grade) in grades 4-12. When a calendar is selected, the report pulls most data from the prior school year (the Minus One Year). For example, if the 23-24 calendar is selected, the report pulls student's initial grade from the Minus One Year: 22-23, and compares to the grade in the Zero Year, 23-24.
KY State Reporting	<a href="#">SAAR Report</a>	<b>Superintendent's Annual Attendance Report (SAAR) Enrollment Report</b> The SAAR provides a summary of each district's attendance data for the entire school year. The Summary report types provide aggregate data suitable for state submission. The Detail report types provide student- level data for verification, analysis and reference.
