This data entry deadline has been extended to **May 1**st due to the recent weather affecting many of our school districts. KDE will extract the data at that time to obtain the required review and approval of the Commissioner. This data will also be used to compare to district amended calendars that can be submitted through the application starting May 15.

This collection is relevant to the original ten (10) NTI day allowance for the school year. The five (5) additional disaster relief student attendance days allowed by <u>House Bill 241</u>, should only be requested for use after a district utilizes the ten (10) day NTI allowance. The approval and data collection for the disaster relief student attendance days requires a different process that can be referenced in KDE's Guidance on House Bill 241 (2025 Regular Session) Calendar Provision for additional information.
