## CTE End-of-Program (EOP) Assessment scores for articulated credit available in Infinite Campus for transcripts (Data being pushed beginning May 9th)

The Kentucky Department of Education (KDE) will begin publishing CTE End of Program (EOP) Assessment scores to Infinite Campus on Tuesday, May 9, for students meeting benchmark in 2023. Students who passed the CTE EOP assessment and met other requirements identified in the <u>statewide</u> <u>articulation agreements</u> may request articulated credit with postsecondary partners. Districts are asked to turn on CTE assessments for transcripts in IC to document this student achievement and assist with documentation for articulated credit.

The CTE EOP assessment (previously KOSSA) has been redesigned to display on the student's transcript only when the student has passed the assessment. Please go to Assessment | Test Setup in Infinite Campus and select each of the CTE EOP assessments to make sure the "Display in Transcript" box has been selected in order for the CTE EOP assessment to be displayed on the student's transcript. Make sure the "Scale Score" and "Result "boxes are unchecked.
