Infinite Campus/Mosaic Eligibility Year Update Reminder

Districts that utilize Mosaic, and therefore the daily automation of direct certification and eligibility records, should follow the attached instructions to update their FRAM eligibility year in Infinite Campus for the new school year. Mosaic will automatically restart the automation to import direct certification records and export eligibility records to Infinite Campus beginning 8/1/2026. Districts that utilize MySchoolApps for online HIFs should reference the second page of instructions as well.
