Infinite Campus Release Highlights – Campus.2631
Kentucky Specific

Item	Description
Career Readiness	Kentucky Career Readiness reporting and setup received updates including new state course codes, additional CIP codes, and refinements to Career Readiness Report validations. These changes improve reporting clarity and support new 2026-27 program offerings.
ILPA	The ILPA tool no longer stores student Social Security Numbers when Refresh Student Data is used and the document is saved. This reduces unnecessary storage of sensitive information.
SAAR	Multiple SAAR corrections were delivered, including fixes for the RW Ten Low Attendance Weather Days report and Record 9 reporting scenarios. These updates improve attendance reporting accuracy.

Core Product

Item	Description
Campus Instruction	Classroom Messenger now allows teachers to communicate with students who have future roster start dates before the term begins. This is particularly beneficial for cross-site enrollment scenarios.
Campus Learning	Curriculum Import received multiple enhancements that improve handling of file names and imports. Additional corrections restore question bank functionality and allow editing of questions containing images.
Census	Summer EBT enhancements add address management capabilities to support mailing requirements and improve state synchronization processes.
Learner Planning	Service Summary Report and related Special Education reports were updated to better leverage District Residency data. Additionally, Special Education document archiving has begun rolling out to convert historical documents into PDFs for long-term retention.
Scheduling	Scheduling Board and related scheduling tools received enhancements to cross-site enrollment, course management, section rosters, walk-in scheduling, and alternate request processing. These improvements provide better data consistency and easier schedule management.
Security	SAML Identity Provider Configuration was enhanced to improve metadata handling and parent/student association capabilities. Additional fixes improve navigation reliability within User Account Administration.
Transportation	Transportation records now display correctly in Campus Student and Campus Parent, restoring visibility of transportation information for families.

Item	Description
Transcript	Transcripts now refresh automatically when navigating between students, and portal transcript comments display correctly.

Item	Description
Attendance	Attendance Refresh was corrected so attendance data is properly cleared for students who are not enrolled in attendance-taking courses. This change improves attendance accuracy and reduces manual cleanup before state reporting cycles.
State Reporting	English Learners Extract received updates to reporting elements. Safe Schools Report was corrected to properly generate warning conditions. SAAR Record V was corrected to prevent inflated attendance calculations. SAAR District Daily Attendance Report now displays low-attendance indicators when run independently. Testing Roster Extract contains updated KDE guidance text.
ILPA / FERPA	Individual Learning Plan Addendum (ILPA) received formatting improvements and updated document references. FERPA received revised labels and a new field to support HB307 Kentucky's Proactive Postsecondary Admissions program participation.
Transportation	Transportation 2.0 now exposes Transportation Code values through Ad Hoc Reporting, allowing districts to incorporate transportation data into custom analyses and local reporting solutions.

Item	Description
Academic Planning	Academic Program security and Batch Program Assignment Wizard performance issues were corrected, improving administration of academic programs.
Assessment	Assessment Center test-copy functionality was improved so complex mapping configurations are preserved when tests are copied.
Campus Instruction	Grade Book and Categories updates resolved issues affecting course comments, score saving, and guest grading access.
Census	Mailing Labels, Staff Account Automation, and DIS stability improvements increase reliability and reduce processing issues. The Census by Birth Date Report has been fixed.
Forms/Documents	Custom Forms synchronization, printing, and State Edition rights were enhanced, including support affecting ILPA workflows.
Learner Planning	Special Education reporting, team member management, service logging, document handling, and eSignature processing received multiple improvements.
Messenger	Messenger 2.0 enhancements improve message processing visibility, Mailgun batch delivery, and expand access to Sent Message Log 2.0.
Records Exchange	National Records Exchange and Student Records Transfer corrections restore successful IEP import processing.
Scheduling	Scheduling Board, Requests & Rosters, Course Management, Section Roster, and Cross-Site Enrollment functionality received significant usability, validation, and performance improvements
Tuition Billing	Tuition Assignment Wizard, payment-plan due dates, and billing statement terminology were updated to improve billing workflows.
