Reminder – Infinite Campus release Campus.2311 will go into production tomorrow night (4/12). Details for the release were provided in the previous notification below.

- **New** - The SPED Exit Detail Report produces student level data of students, ages 14 to 21, who may have exited from Special Education Services for quality assurance review and verification of data for federal reporting. This report compares the Special Education Exit data on the enrollment record to the KDE Determined Special Education Exit Status and Date. This report is pulled from a table that is refreshed weekly for the active year and has historical data for up to two prior years.

Additionally, please be advised that KDE is planning the release of **Campus.2315** to start **Wednesday, April 26, at 7:00 p.m., (Central)/ 8:00 p.m. (Eastern)**. This is two weeks earlier than planned to reduce interruptions to the end of school processing. Additional information will be provided later this week. Infinite Campus will be temporarily unavailable during the update process.

Infinite Campus Release Highlights – Campus.2311

New Vaccine exemption added	A new vaccine exemption, T: Titer Immune, has been added. KDE will communicate details on usage to nurses.
Safe Schools Report Updates	The Safe Schools Report for 22-23 reporting. <ul style="list-style-type: none"> Removed Critical Error 2: To report all incidents with a state resolution including those without a state event code. Added Critical Error 7: To identify an Interim Alternative Education Setting (IAES) state resolution that exceeds the maximum resolution length of 45 days.
TEDS Automatic End Dates Change	TEDS automatic end dates will now ignore enrollments in summer school calendars.

Core Product

Item	Description
Custom Module Contact Log	Users are now able to select the location of a custom contact log when it is being created using the Custom Module Setup tool.
Messenger 2.0 - Priority Messages	The option to schedule "Priority" messages has been added to the Messenger 2.0 tools. New tool rights have been added for sending Priority messages. A new "Priority" button added to the Create New Message section of Messenger 2.0, between General and Emergency, a new Priority indicator for the Scheduled Messages list, and a new Priority tab has been added in the Select Templates view. Much of the workflow is the same as the other message workflows. Additionally, Priority messages: <ul style="list-style-type: none"> Respect the dial window. Can be scheduled as recurring. Include additional fields and sub-reports beyond what is available for Emergency messages. <p>In support of this update, a new Priority column has been added to Census Messenger Contacts, a new Messenger 2.0 Priority phone number has been added to CalledID Preferences, and Messenger 2.0 - Priority options for Default Delivery Devices in Messenger Settings.</p>
Submitting Assignments on Behalf of Students	Teachers now have the option to submit assignments on behalf of students. The Submissions option displays if the district has Campus Learning and has given the teacher the Enhanced Curriculum tool right. A note at the bottom of the submission indicates when an assignment was submitted for the student by a teacher. Using the View As Student option in the top right corner of the screen, teachers can view the assignment as a student sees it and submit work for the student for assignments that have submissions enabled. Depending on what is enabled for the assignment and what options the teach has available, they can submit text in the Editor, upload a file to the Digital Repository, or attach a file from the teacher's own Google Drive to the assignment. An additional option has been added for Digital Repository users: after clicking Upload File on the submission screen, teachers can select Take a Photo to take a photo using their webcam or phone camera and attach it to the assignment. This option to take a photo is also available to students via Campus Student.
User Account Maintenance Updates	To improve the user experience and better clarify login settings, the following updates were made to the Login Security Settings tool: <ul style="list-style-type: none"> A new section titled 'New Device Notification Settings' has been added. This section contains the following two fields used to control login notifications for new devices: <ul style="list-style-type: none"> Do not send login alerts <ul style="list-style-type: none"> When selected, staff users will not receive a login notification when logging into Infinite Campus using a new, unregistered device.

	<ul style="list-style-type: none"> ○ Send an alert when logging in with a new device. (This option requires email messenger to be configured to function.) <ul style="list-style-type: none"> ▪ When selected, staff users will be prompted to enter and confirm a security email before accessing Infinite Campus and the user will receive an email notification each time a new device is used to log in. Users may skip the verification and log into Infinite Campus but will be reminded periodically to complete the verification process. ● A new section titled 'Two-Factor Authentication Options' has been added. This section contains the following three fields: <ul style="list-style-type: none"> ○ Do not require a verification code to log in <ul style="list-style-type: none"> ▪ When selected, staff users will not be required to use two-factor authentication when logging into Infinite Campus. ○ Require a Two-Factor Authentication code (Email-Based). This option requires email messenger to be configured to function <ul style="list-style-type: none"> ▪ When selected, staff users will be required to enter and confirm a security email before accessing Infinite Campus and will be required to enter and confirm a security code emailed to them each time they attempt to access Infinite Campus. ○ Require a Time-Based Two-Factor Authentication code (Third party authentication application required) <ul style="list-style-type: none"> ▪ When selected, staff users will be required to use an Authentication app in order to login and access Infinite Campus. ○ Both two-factor authentication options allow for the administrator to determine the interval of requiring reauthentication (New Device, 30 minutes, Day, Week, Month) <p>To better clarify two-factor authentication options on the User Account page, the following updates were made:</p> <ul style="list-style-type: none"> ● The 'Time-based Two-factor Authentication w/ Enhanced Security' field was renamed to 'Time-Based Two-Factor Authentication'. ● The 'Exclude From Multi-Factor Authentication' field was renamed to 'Exclude From Multi-Factor Authentication and new device notifications'.
