In addition to the details provided in the previous release notification, Campus has updated the Special Ed document editor buttons and release logic. KDE has updated the [Mathematics Achievement Fund](#) (MAF) report to include all students enrolled in grades 00-05 at schools receiving the MAF grant. Assigning tool rights will ensure KDE reports are available to those needing access.

Special Ed Documents Responsive Buttons Enhancement	When users decrease the size of the screen while working in a Special Ed Document, certain buttons now display as an option within a new split button, Actions.
Special Ed Document Editor Release Logic	Logic for when one user releases an editor and makes it available to be edited by another user has been updated. An editor is released when the user: <ul style="list-style-type: none">• navigates to the next editor by clicking Save and Next, or by clicking the Editors button and selecting the next editor from the side panel.• clicks the Cancel button to return to the Editor Home screen.• logs out of the Campus application.• navigates to a different tool in the Campus application.

SAAR Report	Issues with positions and formatting on the SAAR Report have been corrected.
Special Ed IEP Update	<p>Logic has been updated on the Kentucky Individual Education Plan (IEP) when after both the Alternate Assessment Participation Guidelines and Learner Characteristics Inventory editors are completed AND data is then removed from the Guidelines editor, the Learner Characteristics Inventory editor is automatically placed in a Not Needed status.</p> <p>Verbiage on the Alternate Assessment Participation Guidelines editor on the IEP has been updated. This change is also reflected in the printed document.</p>

Assessment	The Child Test section and other settings in the Assessment Center has been updated to enhance user experience.
Behavior	An issue where users were unable to delete Behavior Incidents from a Behavioral Referral until the admin notification was deleted first has been resolved.
FRAM	<p>After a parent or guardian had completed the Meal Benefits application on the Portal, the Print Letter from their Inbox message displayed a blank screen on the Mobile app. This has been corrected.</p> <p>When users have calendar rights assigned to them through a user group, they would receive an "Unable to load calendar rights" error when they open the Eligibility Eligibility tool. This has been corrected.</p> <ul style="list-style-type: none"> If a student had an Eligibility with a direct type code that doesn't match a code in the Campus dictionary, the Eligibility Eligibility page would not load. This has been corrected.
Grading Setup	<p>The Grading by Task and Grading by Student tools have been updated to sort standards by the same logic as the Standards Bank.</p> <p>The Grade Calc Options tools for Courses and Course Masters have been updated to display corrected in the New Look of Campus.</p>
Insights	<ul style="list-style-type: none"> Templates available for selection in the Insights Dashboard failed to filter based on the report selected. This issue was corrected.
Messenger	<ul style="list-style-type: none"> Messenger 2.0 Recipient List Enhancement added the ability to filter student/messenger contact lists by bus lists.
Navigation – New Look	<p>A Contact Information section has been added to the Person Information card. Person Information card. This new section will display the following information for the person's listed contacts:</p> <ul style="list-style-type: none"> Last Name, First Name MI Cell Phone #

	<ul style="list-style-type: none"> • Work Phone # • Other Phone # • Pager # • Email Address • Secondary Email Address <p>If the Person Information card is for a student, each of the student's guardians will display this information with the addition of their Relationship to the student.</p> <p>There are also now links to Demographics and the Student Summary. A link to Demographics will only be visible if the person has access to the Demographics tool and the Student Summary will only appear if the person selected is a student.</p>
OneRoster	<p>The Campus implementation of OneRoster 1.2 has been updated to prioritize returning non-secondary addresses over secondary addresses, regardless of which address was added most recently.</p> <p>A new Connection Configuration section has been added for OneRoster 1.2 connections which includes an option to Omit Legal Names. When checked, this option prevents Legal Names from the Protected Identity Information section of an Identity record from being returned via OneRoster 1.2 connections.</p> <p>A new checkbox has been added to enable school scoping when configuring a OneRoster connection. School scoping is disabled if the checkbox is not marked.</p>
Online Payments	<p>Districts can now allocate the cost and benefit of online payment fees to each school's bank account proportionally. Previously, all Transaction and Service Fees were deposited into a separate Fund Account. Transaction and Service Fees were deposited into a separate Fund Account. These fees will now follow the Fund Accounts of the items being purchased. This enhancement streamlines financial tracking and ensures that funds are allocated accurately.</p>
Scheduling	<p>For some students, the Calendar view of their schedule displayed incorrect course information when selecting a specific course, and information for another course displayed. This has been corrected.</p> <p>Start Times and End Times can now be added to Lunch Setup. When a start time is entered, an end time must also be entered. These time fields can also be added to Ad hoc reports.</p> <p>Walk-In Scheduler performance has been optimized.</p>
