Health	The ICD-11 Conditions list was added as an option to the Default Health Condition System Preference. When selected, only ICD-11 and custom conditions display in Campus tools. However, KDE strongly recommends keeping this preference set to ICD-10 to ensure alignment with Medicaid billing requirements and KDE reporting standards. Please note: Medicaid does not reimburse services coded with ICD-11, and using these codes in Campus may result in denied claims.
Message Center	The Message Center has been updated to improve visual design and accessibility. The Message Center in Instruction used by teachers has been renamed Classroom Messenger.
Messenger	Added recipient counts modal that appears after pressing 'Send' in Messenger 2.0, showing the number of unique recipients for each delivery mode and the total number of people included in the recipient list. A recipient report CSV can be generated from this modal for more detailed recipient information prior to sending.
Navigation	Team information has been added back to the student/person title bar.
Surveys	Migrated external surveys from the centralized service to the Student Information System, implementing security improvements like CAPTCHA for external surveys, date restriction checks for survey end dates, dynamic alert error messages, and improved survey functionality and data management within SIS.
System Processes	The <u>Task Scheduler</u> has been updated to a modern look and feel, aligning with current Campus design standards. The visual indicator showing if each task was active or stopped (green or red) has been replaced with an Active/Stopped column, and tasks can now be edited by clicking the Edit button for each task.

Assessment	The tool rights logic was updated for access to the Assessment Center. Changes include:  READ  View Step 1 only.  READ/WRITE  View Steps 1-5.  Access 'Import' under Update Options on Steps 4-5.  READ/WRITE/ADD/DELETE  Full access to Steps 1-5, including 'Replace' test under Update Options on Steps 4-5.  Queries were updated in the State Edition to ensure consistent and timely return of data
Campus Student/Parent	when Test Score data syncs from the District Edition to the State Edition.  When Account Linking is enabled for a state, if an admin logs into a parent's account using the 'Login as User' feature, they did not see the Manage Districts tool for data privacy reasons. Logic has been updated so that admins can see the Manage Districts tool but not information about any linked accounts. This change gives admins a better understanding of what parents and students see.
Campus Instruction	The posting grades process in various Instruction tools has been updated to auto-post grades for students whose Roster End Date is on or after the last day of the term. The workflow for posting grades for students with End Dates has been improved by adding clarifying messages to inform teachers which students will receive posted grades and why.
Campus Learning	The option to submit work on behalf of a student has been extended to include quizzes. For example, a teacher could print out a quiz for a student who needs a paper copy and then enter the student's answers on their behalf.  To submit a quiz for a student, use the View as student dropdown list at the top right of the screen to select a student. Then click Start Quiz and enter the student's answers. The teacher's name is associated with the work they submit for a student. Note: teachers cannot submit a quiz for a student if the student has started the quiz online already.  A Feedback button has been added to various areas of quizzes. This button links to a forum post where users can provide feedback about quizzes, including recent improvements.  The Curriculum Library has been updated to allow users to add single items, such as an assignment or resource, to the Library. Previously, only entire folders of curriculum could be added. If viewing the library with Resources rather than Folders selected in the Content section, new Included Tasks filters allow users filter by items with quizzes, submissions, discussions, or LTI linked content. Assignments with Engagement Check-Ins and those
Classroom Integrations	received via a OneRoster integration cannot be shared to the library.  New icons have been added to applications in the Digital Learning Applications Configuration tool to indicate applications that are fully supported, at risk, and no longer supported. Alerts
Custom	can also be added by Campus to applications if additional information is needed.  Custom Tool Setup has been updated to no longer include New Look as a tool placement option. The 'Classic Look Menu Placement' label has been replaced with 'Placement Location', and users can no longer assign a tool to a Classic Campus location. Note: Users must have proper tool rights for the Custom Tool Placement Editor to place a custom tool in the UI.

Item	Description
Message Center	A new State Announcements section has been added to the redesigned Message Center. For state edition users, one card displays Statewide Announcements and the other displays District Announcements based on the current District context selected. For district users, a new State Announcements card displays notices from state edition.
Security	The Generate Password option on user accounts has been updated to adhere to the Minimum Password Length value set in Account Security Preferences.
