Enrollment	These districts, Kentucky School for the Blind (602), Kentucky School for the Deaf (603), Craft Academy (610), We Lead CS (680), Kentucky Tech System (777), and Kentucky National Guard Youth ChalleNGe Academies (880), were removed from the list of options available on the Enrollment's Dropout/KTS Primary District and Resident District fields.
