**Infinite Campus Release Highlights – Campus.2551**  
**Kentucky Specific**

Item	Description
Enrollment	An issue where the warning message for <a href="#">Enrollment</a> Overlap logic was actually preventing overlapping enrollments was fixed for Kentucky users. Regardless of the system preference warning users, overlapping enrollments are allowed in the system, but must be cleaned up and can be no longer than one day when submitting end of year KY SAAR reports.
Immunization	The Hepatitis B and Tdap vaccine compliance rules were updated for Kentucky. See the Kentucky <a href="#">Immunization Rules</a> article for additional information.
SAAR	<b>REMINDER: Do not enable Transportation 2.0 in production until KDE can fully analyze the impact on funding and functionality.</b> An issue was fixed where the <a href="#">SAAR</a> Record 7 not including transportation codes after the Transportation 2.0 tool was enabled. This has been fixed.

**Core Product**

Item	Description
Grades Reporting	Several updates were implemented for the <a href="#">Student Grades</a> tool: <ul style="list-style-type: none"><li>• Added print functionality to the main Grades screen and section detail screen.</li><li>• Enhanced user experience with a horizontal scroll bar at the bottom of the page for easier viewing of multiple terms and multiple standards/grading tasks.</li><li>• Added capability for a full view option.</li><li>• Grading Information pop-up loads without issue after previously using the ESC key.</li><li>• Refreshing the page when viewing a curriculum item no longer generates an error modal, and Curriculum can be closed as expected.</li></ul> The winter trigger date for the <a href="#">GPA Snapshot Job</a> has been changed from March 31 to January 30. This update ensures accurate capture and storage of class rank, weighted GPA, and unweighted GPA snapshots at the intended times throughout the year.
Student Locator	The <a href="#">Student Locator Wizard</a> functionality has been updated to return match options for students with a space in their name, even when the SSID is unknown. This ensures that the correct person is now returned as a possible match in these scenarios.
School Choice	In April 2027, Infinite Campus will transition away from the current School Choice tools. Users are encouraged to begin utilizing the new Open Enrollment tools with better user focus and expanded functionality. See the knowledge base for more information.
