Item	Description
Assessment Center	Assessment Center has been enhanced to include score import functionality.
Campus Instruction	Keyboard short cuts , along with flags and calendar view have been enhanced and updated.
Data Validation	The scheduling Data Validation Rules have been updated to be run by the school and end year.
Learner Planning	All list editors within Special Ed Documents have been updated with a responsive design to display the number of records based on the size of the user's screen. This enhancement only applies to Special Ed Documents rewritten in the New Look of Campus.
Messenger	The Messenger 2.0 Template side panel would stay open after deleting a template and, if the template side panel was re-opened, the side panel would load indefinitely. This has been corrected.
One Roster	OneRoster performance has been improved for commonly-used queries and endpoints.
Schedule	A new Walk-In Scheduler setting has been added, called Include Blended Learning Group Counts. When turned on, the number of Blended Learning students in the selected section is included in the hover count panel with the Room Number and number of students with IEPs. When turned off, the Blended Learning Students count does not display.
Transcripts	A new school year unweighted GPA identifier has been added to the database: 'YearGPASStats' see Transcript release notes for details.
