Reminder – Infinite Campus release Campus.2319 will go into production tomorrow night (6/14). Details for the release were provided in the previous notification below.

- **New** - The [Assessment Results KSA](#) report provides the prior year's Kentucky Summative Assessment (KSA) scores to help schools review data for students enrolled in the selected school year. The detail report provides individual student scores on all KSA subjects administered the prior year including students who have transferred from other districts. The aggregate report provides results by subject and includes the total enrollment, number of students tested and average score by subgroup. 2023 KSA data should be available in the fall.
- **New** - The [Preschool Child Outcome Summary](#) report is to provide a list of preschool students and the completion status of each student's Child Outcome Summary (COS) form by COS period for data quality review.

Infinite Campus will be removing all NOLOCK (and its equivalent, READUNCOMMITTED) query hints and READ UNCOMMITTED settings from the Infinite Campus code base with Campus.2331. Districts must be prepared to remove any NOLOCK (and READUNCOMMITTED) query hints from your own custom SQL code. Campus.2331 is scheduled for release on Wednesday, September 13. ## Infinite Campus Release Highlights – Campus.2319

### Kentucky Specific

Item	Description
<b>Gifted and Talented</b>	Updates have been made to the Kentucky Gifted and Talented tooling and a new GSSP Report is available and can be shared on the portal.
<b>English Learners</b>	A field titled Date Determined Misidentified has been added to the English Learners (EL) tool for Kentucky. This allows the district to record the date the district determined a student was misidentified as English Learner (EL) and their Program Status changed to Not EL. This field is also available in the LEP tables for Ad Hoc and database reports. Users will not be able to save a record with a date in this field if the Program Status is not equal to Not EL.
<b>TEDS</b>	CIP Code 11.0401.00 Data Science Career Pathway has been added to the TEDS Attribute Dictionary.
<b>Special Education Documents</b>	The Kentucky IEP, Private School Service Plan, Conference Summary, Referral, Consent Form, and Evaluation documents have been completely rewritten with the New Look of Campus. The new print formats for these documents are KY IEP 2023, KY PSP 2023, KY Conference Summary 2023, KY Referral 2023, KY Consent for Evaluation 2023, and KY Evaluation 2023. All other print formats have been archived, but data is retained from these archived print formats for historical purposes.

<b>Assessment - Test Detail Updates</b>	<p>The layout design and functionality of the Test Detail section of the Assessment Center have been updated to enhance user experience:</p> <ul style="list-style-type: none"> <li>• Name of the 'Children' header changed to 'Child Tests'.</li> <li>• New banner added under 'Child Tests' that reads 'Child tests can be re-ordered by dragging and dropping'.</li> <li>• When the cursor is over a child test: <ul style="list-style-type: none"> <li>○ Icon displays as hand.</li> <li>○ Child test is highlighted.</li> </ul> </li> <li>• 'Save' button options updated to include <ul style="list-style-type: none"> <li>○ 'Save' (default)</li> </ul> </li> </ul> <p>'Save &amp; New'</p>
<b>Campus Instruction - Updates to Message Center for Teachers</b>	<p>The Missing Assignment Messages and Grades Messages have been updated so that teachers can send these messages to students, as well as their guardians. In Step 2 of creating a message, Teachers can now select which type of Recipients to include in the message: Messenger Contacts (individuals whose Relationship to a student is marked as Messenger) and Students themselves.</p> <ul style="list-style-type: none"> <li>• When sending the message to all recipients from the section, mark Messenger Contacts or Students, or both.</li> </ul>

	<ul style="list-style-type: none"> <li>When selecting specific recipients, toggle between the two types to create a Recipient List that includes both students and guardians.</li> </ul> <p>In support of this update, the Sent Message Log has also been updated to indicate whether students were included in the message in the Delivery Summary and which Recipient Types were selected in the Filter Criteria Detail. The Recipient Log has also been updated to reflect inclusion of students in Grades and Missing Assignment messages.</p>
<b>Campus Learning - Posted Grades in the Progress Monitor</b>	The Progress Monitor has been updated to allow teachers to show either the students' In-Progress or Posted Grades at the center of each cell in the grid. Use the Displayed Grade toggle at the top of the Progress Monitor to select which type of grade should be shown.
<b>Campus Learning - Progress Monitor Student Search</b>	The Progress Monitor has been updated so that if a teacher has a student search filter or eye icon selected and switches to view a different section, the filter will still be applied, if it is applicable to the new section.
<b>Contact Log</b>	The ability to merge and delete Custom Module Contact Logs has been added to Custom Module Setup. These tools can be used to re-create Contact logs experiencing issues by moving records and removing the now empty Contact Logs.
<b>Data Validation – Five Rules Added to Baseline Validation Rules</b>	<p>Five rules have been added to the base/non-paid version of Validation Rules:</p> <ul style="list-style-type: none"> <li>Active students not in a household</li> <li>Households with more than 1 primary mailing address</li> <li>Students who have no birth date</li> <li>Students who have the same student number</li> </ul> <p>Transcripts with no GPA value</p>
<b>OneRoster - OneRoster Cache Refresh</b>	By default, the OneRoster cache has been updated to refresh between 10pm and midnight local time, initiated at 10:10pm. An option has been added to the Settings menu in Digital Learning Applications Configuration allowing users to set a custom OneRoster Daily Cache Refresh Time. Off-peak hours are recommended.
