Reminder – Infinite Campus release Campus.2331 and Campus.2335 will go into production tomorrow night (9/13). Details for the release were provided in the previous notification below.

Beginning with this release, KDE is creating custom placements for new look for KDE Reports in Reporting | KDE Reports. These cannot be modified using the Custom Tool Placement Editor. If the district previously created custom tool placements for KDE Reports within the Reporting menu, they will be removed to prevent duplication. Users with existing tool rights will automatically have access to the custom tool placements. Assigning tool rights will ensure KDE reports are available to those needing access.

Report changes in this release include:

- NEW The <u>School AED Counts</u> report shows the number of portable automated external defibrillators
  (AED) at each school within the district. The count of AEDs must be entered by year on the School Health
  Information record per the <u>Health data standard</u>.
- Removed The Student COVID-19 Attendance Group Report has been removed.
- Custom tool placements have been created for \*Tableau Aggregated Only and \*Tableau Visualizations in Reporting | KDE Reports.
