Career Readiness	Three State Course Codes were added to the Kentucky Career Readiness tool for the 26-27 school year: • 331037: Teaching and Learning Internship • 331038: Teaching and Learning Co-op

Item	Description
	210227: Flight and Aviation Co-op
Enrollments	Mary E. Britton Middle School was added to the Dropout/KTS Primary School options used in Kentucky enrollments. (Currently in production)
ILPA	The Kentucky ILPA received a new 2026 print format, corrections to duplicate student information printing, and several updated field labels to better reflect current terminology.
Immunizations	Kentucky immunization compliance rules were updated for MMR, Hepatitis A, and Hepatitis B requirements.
Special Education	The Special Education Referral document was updated so the Tier Intervention column displays more of the intervention description, improving readability for staff reviewing intervention history. The Consent for Evaluation document now requires completion of evaluation-related date fields before the document can be saved.
TEDS	Two additional CIP Codes, 51.0913.01 Sports Medicine and 11.0102.01 Artificial Intelligence (AI) and Machine Learning, were added to the TEDs tool for Kentucky.

Item	Description
Academic Planning	Corrected course planning rules for courses offered every other year so they now appear during the correct planning year for students. Updated Academic Program credit evaluation functionality to properly reflect state-published program attributes in District Edition. Resolved a security-rights issue that prevented users from adding students to state-managed academic programs without unnecessary additional permissions. Corrected a standards-based report card issue where recent credit type changes affected grading task behavior and grade reporting.
Assessment	Enhanced Test Score synchronization between District and State Editions by introducing event-driven updates, allowing score changes to synchronize more automatically and efficiently.
Attendance	Improved Classroom Monitor performance by resolving issues that caused excessive loading times for attendance staff.
Campus Instruction	Corrected seating chart display issues when teachers were removed from combined sections. Fixed Grades Messenger filtering so teachers can accurately target students based on selected grading tasks and grades. Corrected Classroom Messenger behavior so students with future roster end dates remain available as message recipients when appropriate. Rolled out the redesigned Seating Charts tool with improved accessibility, flexible classroom layouts, enhanced keyboard navigation, and the ability to copy seating charts between sections and school years.
Campus Learning	Corrected Curriculum Import processing errors occurring when multiple districts imported curriculum through the same application server. Improved accessibility for quizzes that use drag-and-drop question types by enhancing screen reader support.
Census	Expanded Displayed Gender functionality, allowing districts greater control over how gender information is displayed in forms, reports, and security rights throughout Campus.
Classroom Integrations	Updated LTI placement logic so district-defined placements take precedence and integrations behave more consistently across learning tools. Updated OneRoster Assessment Results API documentation. Enhanced OneRoster metadata to include primary organization information for students, teachers, and staff. Added support for Microsoft Education LTI links directly within My Curriculum.

Item	Description
Grading Setup	Increased Standards Import version field limits to accommodate additional frameworks. Updated standards integration references to reflect the rebranding of CASE Network 2 to Satchel Rosetta.
Health	Added new vaccine mapping codes and introduced RSV vaccine support. Improved Generic Immunization Extract logic to more accurately determine compliance status when related vaccinations satisfy requirements. Corrected issues preventing nightly immunization compliance calculations from updating student statuses properly.
Learner Planning	Corrected an issue that could disable the Save button on Special Education Documents after canceling certain workflows.
Messenger	Corrected issues involving canceled scheduled messages and in-progress message cancellation in Messenger 2.0. Added a new Status Reason column to Recipient Log reports, providing additional details about message delivery outcomes. Added Caller ID information to recurring message reporting and exports. Enhanced the Messenger 2.0 sending process by introducing a review step before messages are sent, allowing users to verify recipients and message details.
Program Participation / State Programs	Added support for the Summer EBT federal program, allowing districts to manage student participation records. Corrected FERPA Data Opt Out processing so values can be removed and saved appropriately. Restored missing Modified By information on program records to improve auditing and accountability.
Scheduling	Added helpful course information references directly on Section Information screens so users can more easily view course-level values. Fixed Scheduling Board issues involving Same Teacher, Same Period scheduling rules.
Security	Enhanced password security by automatically hashing database-inserted passwords and enabling password hashing by default.
Transportation	Corrected Transportation 2.0 enrollment visibility issues so students with multiple enrollments in the same calendar are displayed correctly to transportation staff. REMINDER: Do not enable Transportation 2.0 until KDE has confirmed it is ready. There are still issues that impact SAAR.
