Subject: Update to KRS 158.070 Affecting School Poling Places

Good Morning,

During the legislative session this year, House Bill 684 (2025) passed and it amends KRS 158.070. This amendment impacts schools where elections are held.

KRS 117.065 was amended to add subsection (3) which states:

The county board of elections shall notify a local board of education that it intends to designate one (1) or more school buildings as voting places no later than December 1 prior to the election. The county board of elections shall specify which school buildings will be used and the expected dates and times of use.

KRS 158.070(5)(b) was amended to state:

If any school in a district is used as a voting place pursuant to KRS 117.065, the school district may be closed on the days of the election, and those days may be used for professional development activities, professional meetings, or parent-teacher conferences.

This change from "shall" to "may" means if a school building is used as a voting place, the school district may close, but it is not required to do so. However, as reflected in KSBA policy 08.3, KRS 2.190 provides that all schools shall be closed for a Presidential election.
