School Report Card (SRC) Assessment/Accountability Data Available.

Current and prior year Academic Performance and School Accountability domains are now open, and data is available in the [School Report Card \(SRC\) Suite Collection and Approval Portal](#). The Assessment and Accountability data is already final, so there is no need to flag issues within the site. The flag feature and monitor flags tool are not being used for School Accountability and Academic Performance domains so responses will not be provided within the tool. There is a known issue with Academic Performance/ Kindergarten Screen navigation that continues to be addressed, details are provided below.

The Kentucky Department of Education (KDE) wants districts to have time to review all data prior to public release. Known issues continue to impact public release. The [current School Report Card Suite dashboard tool](#) will be sunset at the end of this week, Dec. 15. There is limited time available to compare data previously reported in the dashboard view to the new School Report Card dashboard.

KDE hopes to open the School Report Card publicly as a soft launch the week of Dec. 16. The delay with the request for proposal (RFP) release and awarding of the new contract created a short timeframe for completion of the 2024 SRC. Loading three years vs one year of data created additional complexities. We continue to work through issues with datasets and Section 508 compliance issues that impact public release. Given the holidays are quickly approaching, KDE will not make a formal announcement of the SRC public release before the holidays. This provides additional time for issues to be addressed if they arise.

All SRC data is now available in the Preview tool. Prior year data (2021-2022 and 2022-2023) opened last week. For prior year data, there will be some variance from prior year reporting due to rounding and the way small cell counts are suppressed. Also, note that only 2024 datasets will be available in the new SRC dashboard tool; prior year datasets are available in the [SRC suite with historical datasets](#).

Known issues to currently available data include:

- Academic Performance/ Kindergarten Screen navigation issues may impact data views. There are combinations of demographic selections that can cause the screen to lock and not change as new selections are made. Please verify the screens are updating with new selections. If the data doesn't change, you can go to another screen and then come back to Kindergarten Screen.
- Overview/Faculty, Staff and Community/ Equity: (1) calculations are not consistent with prior year reporting; data is not populated correctly at the school-level; (3) ineffective data is impacted by the number of schools within the district that did not complete the ineffective collector entries and historical data is not displaying correctly; (4) Inexperienced Staff Table only showing current year data regardless of year selected.
- Overview/Faculty, Staff and Community/ Faculty Profile/ Teachers Working Conditions; is not populating for current year (2023-2024). Data is available for prior years (2022-2023, 2021-2022).
