  - (ii) the ability to successfully achieve in classrooms where the language of instruction is English; or
  - (iii) the opportunity to participate fully in society. (ESEA Section 8101(20))

- (C) has not been attending one or more schools in any one or more U.S. states for more than 3 full academic years.
