What are Evidence-based Practices (EBPs)?

- An EBP is an activity, strategy or intervention supported by rigorous research.
- Shown to have a positive effect on student outcomes
- High-quality studies have been conducted
- Reviewed by a reputable organization (e.g., What Works Clearinghouse)



What is WWC?

- Program in the Institute of Education Sciences (IES), developed by the US Department of Education, <u>whatworks.ed.gov</u>
- Evaluates studies on educational programs, practices, products and policies to determine what works, for whom, and under what conditions.
- The WWC reviews and rates existing research using strict standards, then shares those findings in clear, accessible formats on their website.
- Helps educators find evidence about what programs and practices improve student level outcomes.



Why Was WWC Created?

- Too much research, too little time Educators are bombarded with programs claiming to be "research-based." WWC helps identify which ones actually are.
- Every Student Succeeds Act (ESSA) and evidence-based requirements Federally identified schools must use EBPs in grant applications and improvement plans.
 - WWC helps meet those standards by categorizing interventions by evidence levels.



Why Use WWC?

- It Saves Time quick access to evidence-based strategies that have been thoroughly vetted.
- Impact By focusing on proven strategies, WWC supports schools in making choices that maximize limited resources for real student impact.
- It's Free, Nonpartisan and User-Friendly maintained by the U.S. Department of Education, so it's free to access, not tied to publishers or products



What does WWC offer?

Using the What Works Clearinghouse (WWC) to Find What Works



Want to find evidence-based programs and practices in education? The WWC provides several ways to identify which interventions are backed by high-quality evidence of effectiveness.



<u>Practice Guides</u> help educators identify and implement evidence-based strategies.



<u>Intervention Reports</u> help decision makers decide whether to select or continue implementing an intervention.



<u>Individual studies</u> reviewed by the WWC report findings from well-designed and well-implemented research.



Intervention Reports


- Summarizes high-quality research studies that meet WWC standards on a given intervention or practice in education that is often branded and must be purchased
- Details what research says about a program's effectiveness, components, target populations and costs.
- Evidence Snapshots are one-page summaries that offer a quick, at-a-glance view of each intervention's impact
- Provides implementation details, including resources needed and possible costs.

Intervention Reports (2)

- Search or browse
- Use to supplement KDE approved high-quality instructional resources (<u>HQIRs</u>)
- Read 180 Intervention Report

Practice Guides

- WWC Practice Guides combine expert insight and rigorous research to address common educational challenges.
- Puts broad topics into easy-to-use summaries for quick reference.
- Includes practical evidence-based recommendations with classroom examples.
- They are designed for educators and parents.

Practice Guides (3)

What are recommendations?

For each recommendation, the practice guide discusses:

- The Recommendation Includes an actionable recommendation, a summary of the research evidence that supports the recommendation, and a description of how the recommended practice supports student learning.
- **Guidance**Explains how to carry out the recommendation, informed by studies that support the recommendation, as well as the panel's expertise and knowledge of strategies available to help implement the recommendation.
- Potential Obstacles Includes obstacles and advice from the expert panel about how to overcome them.
- Tools and Resources
 Offers practical information and examples to help practitioners implement the recommendation.



Individual Studies

- thousands of citations in the database
- have been reviewed by the WWC and categorized into Every Student Succeeds Act (ESSA) evidence tiers
- You can explore studies that meet WWC design standards to find detailed information about study characteristics and ratings.
- Select options from the filters or enter author/title information into the search box.
